PUBLIC COMMENT

There was no public comment.

NEW BUSINESS

a.) ARPA Grant Funds

Chairman Booth notified the Directors that on October 12, 2021, City Council requested that the EDA accept and manage the appropriated \$200,000 of ARPA(America Rescue Plan Act) funds granted to the City from the Federal Government to assist Poquoson small businesses. The EDA needs to decide if they would like to accept these funds and discuss possible uses for the funds.

Dave Callis discussed the fact that the EDA accepted CARES grant funds and administered distribution of these funds. He suggested that a committee of city staff and EDA directors be

formed to discuss uses for the funds and return at the next meeting with a suggested plan. He informed the group that after coming to decisions on the plan, acceptable uses of funds, application and other plan elements, the documents would be reviewed by a consultant hired by the City to ensure everything meets the intent.

The guidelines for the ARPA grant stipulate the funds must be committed by 2024 and spent by 2026. Since previous grants were used for business rent/mortgage reimbursement, this grant should be used for other purposes.

The Directors discussed some options for funding including outdoor spaces, HVAC replacement/enhancement for air purification, business growth, online presence and sales and determined that the committee will bring suggested options to the next meeting.

Motion to accept ARPA grant funds and administer the program was made by Cliff Bowen and seconded by Director Freeman.
